HAZARDS IDENTIFICATION (ANSI Section 3)

Primary route(s) of exposure : Inhalation, skin contact, eye contact, ingestion.

Effects of overexposure :

Inhalation : Irritation of respiratory tract, lungs. Prolonged inhalation may lead to dizziness and/or lightheadedness, headache, nausea, coughing, sneezing, difficulty of breathing, allergic response, asthmatic reaction, severe lung irritation or damage.

Skin contact : Irritation of skin.

Eye contact : Irritation of eyes. Prolonged or repeated contact can cause tearing of eyes, redness of eyes.

Ingestion : Ingestion may cause mouth and throat irritation, mucous membrane irritation, gastrointestinal disturbances.

Medical conditions aggravated by exposure : Eye, skin, respiratory disorders, asthma-like conditions.

FIRST-AID MEASURES (ANSI Section 4)

Inhalation : Remove to fresh air. Restore and support continued breathing. Get emergency medical attention. Have trained person give oxygen if necessary. Get medical help for any breathing difficulty. Remove to fresh air if inhalation causes eye watering, headaches, dizziness, or other discomfort.

Skin contact : Wash thoroughly with soap and water. If any product remains, gently rub petroleum jelly, vegetable or mineral/baby oil onto skin. Repeated applications may be needed. Remove contaminated clothing. Wash contaminated clothing before re-use.

Eye contact : Flush immediately with large amounts of water, especially under lids for at least 15 minutes. If irritation or other effects persist, obtain medical treatment.

Ingestion : If swallowed, obtain medical treatment immediately.

FIRE-FIGHTING MEASURES (ANSI Section 5)

Fire extinguishing media : Dry chemical or foam water fog. Carbon dioxide. Closed containers may burst if exposed to extreme heat or fire. In closed tanks, water or foam may cause frothing or eruption.

Fire fighting procedures : Water may be used to cool and protect exposed containers. Firefighters should use full protective clothing, eye protection, and self-contained breathing apparatus.

Hazardous decomposition or combustion products : Carbon monoxide, carbon dioxide, acrylic monomers.

ACCIDENTAL RELEASE MEASURES (ANSI Section 6)

Steps to be taken in case material is released or spilled : Comply with all applicable health and environmental regulations. Eliminate all sources of ignition. Ventilate area. Spills may be collected with absorbent materials. Evacuate all unnecessary personnel. Place collected material in proper container. Spilled material is extremely slippery. Complete personal protective equipment must be used during cleanup. Large spills - shut off leak if safe to do so. Dike and contain spill. Pump to storage or salvage vessels. Use absorbent to pick up excess residue. Keep salvageable material and rinse water out of sewers and water courses. Small spills - use absorbent to pick up residue and dispose of properly.

HANDLING AND STORAGE (ANSI Section 7)

Handling and storage : Store below 100f (38c). Keep from freezing.

Other precautions : Use only with adequate ventilation. Do not take internally. Keep out of reach of children. Avoid contact with skin and eyes, and breathing of vapors. Wash hands thoroughly after handling, especially before eating or smoking. Keep containers tightly closed and upright when not in use. Avoid conditions which result in formation of inhalable particles such as spraying or abrading (sanding) painted surfaces. If such conditions cannot be avoided, use appropriate respiratory protection as directed under exposure controls/personal protection.

EXPOSURE CONTROLS/PERSONAL PROTECTION (ANSI Section 8)

Respiratory protection : Control environmental concentrations below applicable exposure standards when using this material. When respiratory protection is determined to be necessary, use a NIOSH/MSHA (Canadian z94.4) Approved elastomeric sealing- surface facepiece respirator outfitted with organic vapor cartridges and paint spray (dust/mist) prefilters. Determine the proper level of protection by conducting appropriate air monitoring. Consult 29CFR 1910.134 For selection of respirators (Canadian z94.4).

Ventilation : Provide dilution ventilation or local exhaust to prevent build-up of vapors.

Personal protective equipment : Eye wash, safety shower, safety glasses or goggles. Impervious gloves, impervious clothing.

STABILITY AND REACTIVITY (ANSI Section 10)

Under normal conditions : Stable see section 5 fire fighting measures

Materials to avoid : Oxidizers, acids, hydrogen fluoride.

Conditions to avoid : Elevated temperatures, contact with oxidizing agent, freezing, sparks, open flame.

Hazardous polymerization : Will not occur

TOXICOLOGICAL INFORMATION (ANSI Section 11)

Supplemental health information : No additional effects are anticipated

Carcinogenicity : Contains formaldehyde, a potential cancer hazard. Rats exposed to formaldehyde via inhalation developed cancer of the nasal cavity. Evidence in humans is limited (nasal and nasopharyngeal cancer). Formaldehyde is listed as a carcinogen by OSHA, probable human carcinogen (group 2a) by IARC, and anticipated human carcinogen by NTP. Overexposure can cause eye, skin, and respiratory tract irritation, and skin and respiratory sensitization. In a lifetime inhalation study, exposure to 250 mg/m³ titanium dioxide resulted in the development of lung tumors in rats. These tumors occurred only at dust levels that overwhelmed the animals' lung clearance mechanisms and were different from common human lung tumors in both type and location. The relevance of these findings to humans is unknown but questionable. The international agency for research on cancer (IARC) has classified titanium dioxide as possibly carcinogenic to humans (group 2b) based on inadequate evidence of carcinogenicity in humans and sufficient evidence of carcinogenicity in experimental animals.

Reproductive effects : No reproductive effects are anticipated

Mutagenicity : No mutagenic effects are anticipated

Teratogenicity : No teratogenic effects are anticipated

No ecological testing has been done by akzo nobel paints llc on this product as a whole.
